On February 4, 2015, Mathew Weaver ("hearing officer") conducted the fourth consolidated pre-hearing conference ("conference") in the above-referenced matter. At the conference the applicant reported he was unable to reach a settlement with all of the parties and requested that the hearing officer proceed with scheduling the formal hearing. The parties discussed whether to schedule the formal hearing or postpone the hearing following completion of the Wood River Valley Groundwater Flow Model ("model"). The model is currently under development in a partnership between the Idaho Department of Water Resources ("Department") and the United States Geological Survey. The best estimate for completion of the model is the fourth quarter of 2015, with implementation and utilization of the model by the Department following sometime thereafter. Following discussion, the hearing officer decided to schedule a formal hearing in this matter. In addition, the hearing officer agreed to schedule deadlines for the parties to adhere to in preparation for the hearing.

At the conference several parties requested an opportunity for public testimony regarding the proposed applications for permit. After consideration, the hearing officer agreed to provide a two-hour block of time between the hours of 5 p.m. and 7 p.m. for public testimony.

Parties also requested that all documentation associated with this contested case be posted to the Department's internet webpage. The hearing officer has agreed to post previous Department notices in this matter; the Idaho Fish and Game's Preliminary Draft Report titled *Rationale for Protest of Permit Applications 37-22682 and 37-22852* dated December 11, 2014: and all future documentation on the Department's internet webpage at the following link:
