DEMPSEY TRUST/ESTATE'S PETITION REQUESTING DEFAULT ORDER NOT BE ENTERED

The Curran D. Dempsey Disclaimer Trust, by and through its trustees Michael C. Dempsey and Curran C. Dempsey, and the Estate of Carmela G. Dempsey, by and through its personal representatives, Michael C. Dempsey and Curran C. Dempsey, Petitioner herein, hereby file this *Dempsey Trust/Estate's Petition Requesting Default Order Not be Entered*; pursuant to IDAPA 37.01.01.701. The Petitioner asserts as follows:

)

On May 22, 2017, Hearing Officer Shelley Keen held a prehearing conference in the above-entitled matter in Coeur d'Alene, Idaho. I, Michael Dempsey, planned to attend the hearing for the Dempsey Trust/Estate, but my wife Nancy had a mental health emergency the day before, which situation did not fully resolve until the weekend of June 3-4, 2017, with the assistance of her local psychiatrist. Fortunately, my brother Curran Dempsey attended a portion of the hearing and make an appearance on behalf of the Dempsey Trust/Estate.

My wife's condition fluctuates during the year, where she can go several works in a perfectly normal and functional state, and then relapses for a period of weeks into a condition where she experiences extreme anxiety and has difficulty leaving the house. This last episode is one of the worst I can recall, and created great pressure on me to assist her, and the need to take time off from my full-time job as hearing examiner with Spokane County to be with her at home.

I operate a 2-person office in my job as hearing examiner, and on May 25, 2017, my wonderful staff assistant of seven (7) years left my office to take a promotion in another County department. For the past several weeks I have functioned without a staff assistant, which has put added pressure on me at work, along with the situation at home described above. I will probably not have the position filled until mid-July.

DEMPSEY PETITION RE DEFAULT -1-

On May 26, 2017, the hearing officer issued the Order Regarding Intervention; Order Requiring Submittal of Information ("Order"). I took this order seriously; although at first I was unsure whether the order applied to the Dempsey Trust/Estate, because the Order created an exception for parties represented by counsel at the prehearing conference, my brother and I are both attorneys, and we appeared for the Dempsey Trust/Estate in our representative capacities. However, we decided we needed to fill out the form and send it in. I have attached a copy of the email I sent to my brother Curran on May 31, 2017, to which I attached a copy of the form required by the Order, and in which I recommended how the form should be filled out. I talked to Curran on the telephone after the email was sent, and Curran concurred with my email on how we should complete the form.

I believed that I completed the form as described in the email and timely mailed it in to the Idaho Department of Water Resources ("Department") in Coeur d'Alene at the address listed in the form, before June 5, 2017; and put away my file until I received information on further proceedings in this matter. On Monday, June 19, 2017, a manila envelope sent by certified mail was delivered to my home; which contained copies of the various orders issued by the hearing officer in the above-entitled matter, including the Notice of Proposed Default Order dated June 14, 2017. I was shocked to read that the hearing officer did not receive a completed form from the Dempsey Trust/Estate, and assumed that this was a mistake.

I checked my files and was surprised to find an unused envelope addressed to the Department in Coeur d'Alene, with my name and address listed for the return address and an unused stamp affixed to the right upper corner. I also found the form which the hearing officer had sent on May 26, 2017. I am still having trouble convincing myself that I did not send the form in, which was my decided intent.

I am a very careful and responsible person in legal matters, and I can say that in over 26 years of practicing law as an attorney have not missed a procedural deadline. I took meticulous care in preparing the petition to intervene submitted by the Dempsey Trust/Estate, including providing more detail than other intervenors on the basis for seeking intervention and my email address.

Based on my uncommon personal circumstances, which I believe caused my inadvertent failure to submit the form by June 5, 2017, I request the hearing officer to exercise his sound discretion and find good cause for my failure to timely submit the form.

I am very embarrassed by this situation, apologize to the hearing officer for the time and expense that the officer has gone to enter and issue the Notice of Proposed Default Order, and represent that with the assistance of my brother Curran there will be no more lapses of procedure by the Dempsey Trust/Estate. I would be happy to reimburse the Department for the expense of providing notice to me by certified mail.
