I am requesting to be an intervenor in the Case No. PFCD-2018-01, Petitions filed with the Department regarding appointment of Gordon Sylte as a Commissioner of Flood Control District No. 17. I understand the Pre-Hearing conference is being held on March 21, 1019 at 2PM at 22787 N. Twinlow Rd, Rathdrum, ID 83858. I have confidence in IDWR to conduct a fair hearing and think I can offer insight to assist with the process without clouding the important issues.

For the past 25 years I have witnessed how Gordon Sylte has fulfilled his responsibilities as a Commissioner on a daily basis 365 days a year. I also have firsthand knowledge as to how he has communicated with other commissioners as well as how he has consistently worked to avoid any conflicts of interest.
