I, Susan Goodrich hereby file a petition to intervene in Case # PFCD-2018-01.

I have a direct and substantial interest as a property owner, taxpayer and water right holder on Rathdrum Creek below Twin Lakes dam. Mr. Sylte has accurately represented me and continues to do so according to the duties and responsibilities outlined in Idaho Code Title 42 Chapter 31 and the mission statement of Flood Control District #17. His removal could put my property as well as that of other property owners on the creek at risk.

Further, Mr. Finman in his letter of 12/14/2018 (p. 3 #8) names me as being a person influencing a FCD vote in reference to water right 95-0734. I have a substantial interest in addressing this statement.

Another direct and substantial interest is that an individual/group promoted (and got passed into law) legislation targeted specifically at one person. (Finman p. 3 #9) ...."what I call the "Remove Gordon Sylte as commissioner law."

As to the litigation creating a conflict of interest to which some of the letters refer, I am directly involved and named as a petitioner in that docket #46062. Paul Finman, TLIA and several parties involved in Case #PFCD-2018-01 intervened in docket #46062 thus actually creating conflicts of interest on their parts. This has resulted in a substantial concern to me as to what their intent in Case #PFCD-2018-01 is really about.

According to the statement in Mr. Spackman's April 30, 2019 order regarding the scope of the hearing and the above references, my intervention does not unduly broaden the issue beyond statements by the protesting parties.
