NOTICE OF HEARING LOCATION


On April 30, 2019, the Director of the Idaho Department of Water Resources (“Department”) issued an order setting this matter for hearing on **August 19-23, 2019**. *Initial Notice of Parties; Order Denying Intervention and Setting Intervention Deadline; Notice of Hearing; Order Authorizing Discovery and Scheduling Order* (“Notice”) at 4. The Notice stated, “The hearing location, in or around Coeur d’Alene, Idaho, has yet to be determined but will be communicated to the parties as soon as reasonably possible.” *Notice* at 3.

The Department has found a location for the hearing. **The hearing will take place at the Idaho State Police conference room located at 615 West Wilbur Ave., Coeur d’Alene, ID 83815. The hearing will commence promptly at 9:00 am on Monday August 19, 2019.**

The hearing will be held in accordance with provisions of Chapter 17, Title 42, and Chapter 52, Title 67, Idaho Code, and the Department’s Rules of Procedure, IDAPA 37.01.01. The hearing will be conducted in a facility that satisfies the accessibility requirements of the Americans with Disabilities Act.
