OTHER TERMS AND CONDITIONS:

THIS PERMIT OR LEASE IS ISSUED UNDER THE AUTHORITY OF SECTION 416, PUBLIC LAW 111-88 AND CONTAINS THE SAME MANDATORY TERMS AND CONDITIONS AS THE EXPIRED OR TRANSFERRED PERMIT OR LEASE. THIS PERMIT  
MAY BE CANCELED, SUSPENDED, OR MODIFIED, IN WHOLE OR IN PART TO MEET THE REQUIREMENTS OF APPLICABLE LAWS AND REGULATIONS.

THIS EXCHANGE OF USE AGREEMENT:

1. CONVEYS NO RIGHT, TITLE OR INTEREST HELD BY THE UNITED STATES IN ANY LANDS OR RESOURCES
2. IS SUBJECT TO (A) MODIFICATION, SUSPENSION OR CANCELLATION AS REQUIRED BY LAND PLANS AND APPLICABLE LAW; (B) ANNUAL REVIEW AND MODIFICATION OF TERMS AND CONDITIONS AS APPROPRIATE; AND (C) THE TAYLOR GRAZING ACT, AS AMENDED, THE FEDERAL LAND POLICY AND MANAGEMENT ACT, AS AMENDED, THE PUBLIC RANGELANDS IMPROVEMENT ACT, AND THE RULES AND REGULATIONS NOW OR HEREAFTER PROMULGATED THEREUNDER BY THE SECRETARY OF THE INTERIOR.
3. MAY BE CANCELLED OR MODIFIED BY THE BLM IF THE AUTHORIZATION HOLDER LOOSES CONTROL OF THE LANDS OFFERED IN EXCHANGE OR VIOLATES THE TERMS AND CONDITIONS OF THIS AGREEMENT, OR IF THE BLM LANDS NOW AUTHORIZED FOR GRAZING UNDER THIS AGREEMENT BECOME NO LONGER AVAILABLE FOR LIVESTOCK GRAZING
4. CAN BE CANCELLED BY EITHER PARTY AT ANY TIME BY PROVIDING THE OTHER PARTY WITH A 30 DAY WRITTEN NOTICE THAT THEY ARE WITHDRAWING FROM THE AGREEMENT.
5. IS BASED ON THE INFORMATION SUBMITTED ON THE APPROVED 'APPLICATION FOR EXCHANGE OF USE AGREEMENT' DATED \_\_\_\_\_(date) ON FILE WITH THE BUREAU OF LAND MANAGEMENT.
