Dear Ms. Tschohl:

We are writing in response to your Freedom of Information Act (FOIA) request, which the Bureau of Land Management (BLM) Idaho State Office received on May 25, 2022. In your request you ask for:

A copy of the following documents, or documents containing the following information, be provided to me: 1) all active federal grazing permits or leases on the federal grazing allotment in Idaho known as the Fourth of July Creek Allotment; and 2) any agency agreements made within the last five years for the purpose of establishing and maintaining stockwater rights on the federal grazing allotment in Idaho known as the Fourth of July Creek Allotment. The allotment is likely managed by the Salmon/Cobalt Ranger District of the Salmon-Challis National Forest.

After a thorough search of our files, we have determined that the BLM has no records responsive to your request.

I am responsible for this decision, in consultation with Mel Meier, Attorney-Advisor for the Department of the Interior, Office of the Solicitor, Boise, Idaho.

We do not bill requesters for FOIA processing fees when their fees are less than \$50.00, because the cost of collection would be greater than the fee collected. *See* 43 C.F.R. § 2.37(g). Therefore, there is no billable fee for the processing of this request.

Under 43 CFR §§ 2.57 – 2.59, you may appeal our "no record response" by filing an appeal by mail, courier service, facsimile, or e-mail to the FOIA/Privacy Act Appeals Officer. The FOIA Appeals Officer must receive your FOIA appeal **no later than 90 workdays** from the date of

this letter. Appeals arriving or delivered after 5:00 p.m. (Eastern Time) Monday through Friday will be deemed received on the next workday.

<u>Your appeal must be made in writing</u>. You may submit your appeal and accompanying materials to the FOIA/Privacy Act Appeals Officer by mail, courier service, fax, or e-mail. All communications concerning your appeal should be clearly marked with the words: "FREEDOM OF INFORMATION APPEAL." You must include an explanation of why you believe the BLM's response is in error.

You must also include with your appeal copies of all correspondence between you and BLM concerning your FOIA request, including your original FOIA request and BLM's response. Failure to include with your appeal all correspondence between you and BLM will result in the Department's rejection of your appeal, unless the FOIA/Privacy Act Appeals Officer determines (in the FOIA/Privacy Act Appeals Officer's sole discretion) that good cause exists to accept the defective appeal.

Please include your name and daytime telephone number (or the name and telephone number of an appropriate contact), email address and fax number (if available) in case the FOIA/Privacy Act Appeals Officer needs additional information or clarification of your appeal. Your appeal must be in writing and addressed to the FOIA/Privacy Act Appeals Office listed below.
