MOTION TO SUPPLEMENT THE ADMINISTRATIVE RECORD AND TO AMEND REQUESTED RELIEF

Perpetua Resources Idaho, Inc. ("Perpetua"), through undersigned counsel, and pursuant to the Department's Rules of Procedure, IDAPA 37.01.01, hereby moves to supplement the administrative record and to amend its requested relief in this matter. This motion is based on the Memorandum in Support filed concurrently herewith and the exhibits attached thereto.

Perpetua respectfully requests that the Director supplement the administrative record in this matter with the August 8, 2024 Memorandum issued by U.S. Department of the Army regarding the importance of the Stibnite Gold Project to national security, and the Endangered Species Act Section 7(a)(2) Biological Opinion and Magnuson-Stevens Fishery Conservation and Management Act Essential Fish Habitat Response for the Stibnite Gold Project ("BiOp"), issued on October 7, 2024 by the National Marine Fisheries Service.

In light of the issuance of the BiOp, Perpetua moves to amend the relief requested in its Exceptions to Preliminary Order filed on May 23, 2024, to be consistent with the BiOp, as described in the accompanying memorandum.
