MUNICIPAL PROVIDERS' MOTION TO AMEND SCHEDULING ORDER

IN THE MATTER OF BIG WOOD RIVER GROUND WATER MANAGEMENT AREA

City of Ammon, City of Bellevue, City of Hailey, City of Idaho Falls, City of Pocatello, Coalition of Cities¹, Falls Water Co. Inc., Veolia Water Idaho, Inc., and Wellsprings Group, LLC (collectively, the "Municipal Providers"), by and through their respective counsel of record, and pursuant to the Idaho Department of Water Resources ("IDWR") Rules of Procedure 220 and 300, IDAPA 37.01.01.220 and .300, hereby move the Director of IDWR for an order amending the schedule set forth in his March 31, 2023 *Order Consolidating Proceedings for Hearing, Authorizing Discovery, and Scheduling; Notice of Hearing* ("Order").

Many parties in the above-captioned proceeding, as well as their experts, are involved in the Surface Water Coalition Delivery Call proceeding, IDWR Docket No. CM-DC-2010-001,

("SWC Delivery Call") for which a hearing is scheduled for June 6-10, 2023. That hearing schedule overlaps with the June 9, 2023 expert report disclosure deadline set forth in the *Order* in this proceeding.

Because of the commitments required of the attorneys and experts involved in the SWC Delivery Call, it will be extremely difficult and prejudicial to maintain the June 9, 2023 expert report disclosure deadline. Accordingly, the Municipal Providers respectfully request that the schedule in the *Order* be amended as follows:

July 14, 2023	August 18, 2023	Deadline for each party to deliver to the parties copies of their expert reports. This production deadline applies only to those parties who intend to argue in support of:	
		(a) the Director's conclusion that "[a]pplications for municipal water use and for domestic use from community water systems shall be considered fully consumptive";	
		(b) the Director's issuance of a "moratorium on pending

July 17, 2023 August 21, 2023

Depositions may begin of the experts identified for purposes of meeting the above August 18, 2023 deadline.

All other scheduled dates in in the *Order* should remain unchanged.

Given the short amount of time until the current June 9 deadline for the first expert reports, and pursuant to Rule of Procedure 220.02.f, the Municipal Providers respectfully request that the Director shorten the time limits provided for responding to this motion and issue a decision on an expedited basis before the SWC Delivery Call hearing commences on June 6.

The Municipal Providers had previously reached out to the other parties concerning this proposed schedule amendment but was informed that they wanted to wait until after hearings before the District Court on June 1, 2023. A second email concerning this proposal was sent this morning but at the time of this filing, no response has been received. Because of the urgent and necessary nature of this request, the Municipal Providers ask the Department for the relief requested.
