INTRODUCTION

Watermasters are required to regulate diversions by federal dams and on-stream reservoirs in accordance with the prior appropriation doctrine. Idaho Code § 42-602. Allocation of natural flow to water rights, including on-stream reservoir water rights, are computed and distributed by Watermasters using a water right accounting process. The existing accounting processes in Water District 1 and Water District 63 have become the subject of controversy as a result of concerns and objections expressed by the Bureau of Reclamation (“Bureau”) and some storage water users. The Director (“Director”) of the Idaho Department of Water Resources (“Department”) concludes it is necessary to initiate contested cases for the purpose of resolving the objections to the existing accounting processes for the distribution of water to the on-stream reservoirs in Water District 1 and Water District 63.

While there is some overlap in the concerns and objections raised in connection with the reservoir and accounting systems in Water District 1 and Water District 63, there are significant differences between the two districts, their reservoir systems, and their accounting processes. The Director concludes it is necessary to initiate separate contested cases for Water District 1 and Water District 63. This order pertains to Water District 1.

FINDINGS OF FACT

1. Most of the federal reservoirs in Water District 1 and Water District 63, and throughout the western United States, are “on-stream” reservoirs.¹ The diversion

structures are large federal dams that impound water and fully regulate the streamflows. For instance, at Lucky Peak:

the entire flow of the natural stream has been diverted and stored and become subject to controlled releases. The storage and releases are made possible by the massive and costly structure known as the Lucky Peak Dam and Reservoir. . . . the [Bureau] monitors and manages the stream flow releases from the reservoir on a day-to-day if not hour-to-hour basis.

Memorandum Decision And Order On Cross Motions for Summary Judgment Re: Bureau Of Reclamation Streamflow Maintenance Claim, In re SRBA, Subcase No. 63-6318 (Sept. 23, 2008) (“Lucky Peak Decision”), at 22; *see id.* at 19 (“the entire flow of the river is diverted and then artificially released.”).

2. The operations of the federal on-stream reservoirs in Water District 1 and in Water District 63 are coordinated such that water licensed or decreed to one reservoir often is physically stored in a different reservoir. The reservoirs are operated in this manner to maximize storage in the reservoir system and allow the Bureau the flexibility to operate their reservoir system to accommodate recreation, fisheries, and other concerns without interfering with the accrual to the reservoir water rights.

3. The inflow to an on-stream reservoir may consist of a mixture of water available for storage according to the priority of the reservoir’s water right(s), water that is storable according to the priority of a different reservoir’s right(s), and/or water that is available according to priority to a downstream appropriator of natural flows. Consequently, distributions of water to the federal on-stream reservoirs in Water District 1 and Water District 63 are determined through water right accounting procedures that allow for the releases, operations, and management of on-stream storage, independent from the accrual of natural flow to the on-stream reservoir’s water right.

4. The accounting procedures referenced above have become a source of controversy and litigation. During the past year, the Bureau and some water users have questioned or objected to the accounting methodologies and procedures for “counting” or “crediting” water towards the satisfaction or “fill” of the water rights for the federal on-stream reservoirs in Water District 1 and Water District 63. For instance, the Bureau and some water users raised this issue in the Snake River Basin Adjudication (“SRBA”) proceedings titled “Basin-Wide Issue No. 17.”² Concerns were expressed that the existing accounting methods and procedures are based on “paper fill” but should be based on “physical fill.”³ In his order in Basin-Wide Issue No. 17, Judge Wildman recognized that the question of when or how a water right is considered “filled” is “an accounting

issue which the basin-wide proceeding does not address.”⁴ Judge Wildman suggested that the issue should be explored in a forum where the Department is able to participate in the proceeding so that a full factual record can be developed.⁵

5. The water users and the Bureau also expressed concerns with and objected to existing accounting procedures in Water District 1 and in Water District 63 through direct communications with the Director and Department staff. In an April 15, 2013 letter to the Director, the Chairman of the Boise Project Board of Control asked, “[h]ow do you intend to define ‘fill’ of the storage rights in the Boise? . . . Does ‘fill’ include pass-through flood water when inflow equals outflow [or] water that is stored and then released for flood water?” and “[w]hat is the rationale for defining ‘fill’ as you have, and is there any rule, regulation, or written decision explaining this rationale?”⁶ The Bureau and some water users also filed beneficial use-based storage claims in the SRBA that seek rights to “the volume of water that flowed through the reservoirs” in the highest flow year of record (prior to 1971), on the grounds that “the entire natural flow of the stream” accrues to the reservoir(s) under existing accounting methods and procedures.⁷ The Bureau and the water users also discussed their concerns and objections in informal meetings with the Director and Department staff.

6. No formal administrative record has been developed to document how and why existing accounting procedures “count” or “credit” water towards the satisfaction or “fill” of the water rights for the federal on-stream reservoirs in Water District 1 or those in Water District 63. The existing “records” on these matters are scattered and incomplete. It is therefore desirable to develop administrative records fully documenting how and why existing accounting methods and procedures “count” or “credit” water towards the water rights for the federal on-stream reservoirs in Water District 1 and also in Water District 63.

7. Fully developed administrative records are necessary to: (1) catalogue the concerns and objections raised by the Bureau and the water users that relate to the accounting methods for “counting” or “crediting” water towards the water rights for the federal on-stream reservoirs; (2) resolve potential factual issues raised in the concerns and objections; (3) address concerns and objections that the existing accounting procedures for the federal on-stream reservoirs in Water District 1 and in Water District 63 were not adequately documented or explained to the Bureau and the water users when originally implemented in each of those districts; (4) resolve ambiguities and terminology problems that have at times resulted in confusion and have complicated attempts to define and resolve the concerns and objections raised by the Bureau and the water users.

8. While there is some overlap in the concerns and objections that have been raised in connection with the accounting systems in Water District 1 and Water District 63, the two districts involve different groups of water users with potentially different concerns and/or objections. There are also differences between the two districts, and their federal reservoir systems and operations. These differences are significant. For instance, while all of the federal on-stream reservoirs in Water District 63 are authorized and operated for flood control purposes, *see Water Control Manual For Boise River Reservoirs* (Corps) (Apr. 1985) (“*Water Control Manual*”), only three of the seven federal on-stream reservoirs in Water District 1 are authorized and operated for flood control: Palisades, Jackson Lake, and Ririe reservoirs. *See Reservoir Regulation Manual For Palisades Reservoir* (Corps) (Nov. 1958); *Standing Operating Procedures, Reservoir Regulation, Ririe Dam, Willow Creek, Idaho, Ririe Project, Idaho* (Corps) (Feb. 1978). Further, it appears that flood control standards and operations at each authorized federal reservoir are tailored to the reservoir and/or the particular reservoir system, and governed by specific or individualized authorities, including federal legislation, operational flood control agreements between the Bureau and the Corps, and contracts between the Bureau and water users. *See Lucky Peak Decision* at 4-13, 33-35 (discussing flood control operations and authorities in Water District 63).⁸ Separate processes are necessary to adequately identify and resolve the concerns and objections applicable to the accounting methods and procedures in each district.

CONCLUSIONS OF LAW

1. Chapter 6 of Title 42 of the Idaho Code (“Chapter 6”) governs “Distribution Of Water Among Appropriators.” Idaho Code §§ 42-602 – 42-619. Distributing water among appropriators under Idaho law is an “essential governmental function” accomplished through “water districts” and “watermasters” as supervised by the Director. Idaho Code §§ 42-602, 42-604, 42-605. The Director has “direction and control of the distribution of water from all natural sources within a water district to the canals, ditches, pumps and other facilities diverting therefrom,” and “shall distribute water in water districts in accordance with the prior appropriation doctrine.” Idaho Code § 42-602.

Idaho Code § 42-203B(2); *Order Of Partial Decree For General Provisions In Basin 2, In Re SRBA, Subcase No. 00-92002GP* (Nov. 20, 2012). There are no comparable provisions in the Idaho Code or SRBA decrees that apply in Water District 63, however, and the potential for future development downstream of the Water District 63 reservoir system to adversely affect the storage supply and federal reservoir operations apparently is a significant concern of the Bureau and the Water District 63 water users.

2. The provisions of Chapter 6 addressing the distribution of water to and the regulation of diversions by conventional “facilities” such as “canals, ditches, [and] pumps,” Idaho Code § 42-602, also apply to the diversion facilities for the federal reservoirs that store water under Idaho water rights in Water District 1 and in Water District 63. *See Am. Falls Reservoir Dist. No. 2 v. Idaho Dep’t of Water Res.*, 143 Idaho 862, 878, 154 P.3d 433, 449 (2007) (“AFRD2”) (“One may acquire storage water rights and receive a vested priority date and quantity, just as with any other water right. I.C. § 42-202.”).

3. The diversion “facilities” for the federal on-stream reservoirs in Water District 1 and in Water District 63 are the federal dams that create the impoundments. Idaho Code § 42-602; IDAPA 37.03.01.060.02.d.iv. Thus, the watermasters of Water District 1 and Water District 63 as supervised by the Director must distribute water to and regulate diversions by the federal dams in accordance with the water rights for the federal on-stream reservoirs and the prior appropriation doctrine as established by Idaho law. Idaho Code §§ 42-602, 42-607.

4. As a result of the operation of the federal dams and on-stream reservoirs in Water District 1 and in Water District 63, the storable inflow to a particular reservoir on a particular day may consist of water that is available for storage according to the reservoir’s water right and water available for storage or appropriation according to other rights; and some of the water available for storage according to a particular reservoir’s water right may be physically stored in a different reservoir. Consequently, the distribution of water to, and the regulation of diversions by, the federal on-stream reservoirs in accordance with the prior appropriation doctrine must be accomplished through accounting methods and procedures that determine which flows are to be “counted” or “credited” towards the reservoirs’ water rights.

5. The accounting methods and procedures for “counting” or “crediting” water to the federal on-stream reservoirs in Water District 1 and Water District 63 for purposes of distributing water to the reservoirs and regulating out-of-priority diversions are of significant interest and concern to the Bureau and storage water users. The Bureau holds legal title to the water rights for the reservoirs and the storage water users hold “title to the use of the water.” *United States v. Pioneer Irr. Dist.*, 144 Idaho 106, 115, 157 P.3d 600, 609 (2007).

6. It is necessary, for purposes of identifying and resolving concerns with and objections to the existing accounting methods and procedures in Water District 1 and Water District 63 to develop formal administrative records fully documenting: (1) how and why water is “counted” or “credited” to the water rights for reservoirs pursuant to the existing accounting methods and procedures; (2) the origin, adoption, and development of the existing accounting methods and procedures in; and (3) appropriate changes, if any to the existing procedures as they may relate to federal flood control operations.

7. There are significant differences between Water District 1 and Water District 63 in terms of water users, size, structure, hydrology, federal reservoir systems and operations, and water right accounting. Therefore, separate proceedings for each district are necessary to fully and efficiently develop the administrative records with a minimum of confusion and delay.

ORDER

IT IS THEREFORE ORDERED that a contested case and formal proceedings pursuant to Idaho Code § 67-5240 and IDAPA 37.01.01.104 are hereby initiated for the following purpose:

TO ADDRESS AND RESOLVE CONCERNS WITH AND/OR OBJECTIONS TO HOW WATER IS COUNTED OR CREDITED TOWARD THE FILL OF WATER RIGHTS FOR THE FEDERAL ON-STREAM RESERVOIRS PURSUANT TO EXISTING PROCEDURES OF ACCOUNTING IN WATER DISTRICT 1

A similar order is being issued with respect to reservoir water rights accounting in Water District 63.

IT IS FURTHER ORDERED that water users with rights to divert, store, or use water in Water District 1 that have concerns and/or objections regarding how water is counted or credited toward the fill of water rights for the federal on-stream reservoirs in Water District 1 are to submit statements of the concerns and/or objections to the Department. Statements shall provide a brief explanation of the basis for and reasons supporting the concerns or objections.

IT IS FURTHER ORDERED that water users submitting statements of concern and/or objection shall include an explanation of the modification they wish to have considered in this proceeding, including an explanation of the basis for and reasons supporting the proposed modification.

IT IS FURTHER ORDERED that water users with rights to divert, store, or use water in Water District 1 that support how water is counted or credited toward the fill of water rights for the federal on-stream reservoirs in Water District 1 may submit statements in support of the current accounting method.

IT IS FURTHER ORDERED that statements must be captioned as above as received by the Department no later than **December 4, 2013**.

IT IS FURTHER ORDERED that a status and scheduling conference will be held on **December 9, 2013**.

NOTICE OF STATUS CONFERENCE

NOTICE IS HEREBY GIVEN that the Director will conduct a status conference on this matter at **1:30 pm, on December 9, 2013**, or as soon thereafter as may be heard, at the **Clarion Inn-Pocatello, 1399 Bench Road, Pocatello, Idaho**.


