**SECOND AMENDED NOTICE
OF STATUS CONFERENCE**

BACKGROUND

On December 21, 2021, the Director of the Idaho Department of Water Resources (“Department”) issued an *Amended Notice of Status Conference* (“Notice”) in the above-captioned matter. The status conference will be held in accordance with provisions of Chapters 2 and 17, Title 42 and Chapter 52, Title 67, Idaho Code, and the adopted Rules of Procedure of the Department, IDAPA 37.01.01. 
