BACKGROUND

On April 29, 2016, the Idaho Department of Water Resources (“Department”) issued a *Preliminary Order Suspending Rotation Credit in Water District 34* (“Preliminary Order”) in the above-captioned matter.¹

On May 10, 2016, the Director of the Department (“Director”) received a letter from Moj and Debbie Broadie, contesting issuance of the Preliminary Order and requesting a hearing. On May 11, 2016, Melvin Marx Hintze and Darla Ann Hintze submitted a letter to the Department seeking reconsideration of the Preliminary Order. On May 12, 2016, Loy Pehrson submitted to the Department a *Petition for Reconsideration and Request for Hearing*. On May 12, 2016, counsel for Nelson Mackay Ranch, LLC et al. filed a *Brief and Exceptions to Preliminary Order Suspending Rotation Credit in Water District 34* contesting issuance of the Preliminary Order and requesting a hearing.²

On May 17, 2016, the Director issued an *Order Granting Requests for Hearing; Notice of Pre-Hearing and Hearing* granting the requests for hearing and scheduling a pre-hearing conference on May 26, 2016, and a hearing on June 22-23, 2016.

The Director held a pre-hearing conference on May 26, 2016. Based upon and consistent with discussions at the pre-hearing conference, the Director will amend the hearing date, authorize discovery, and adopt a schedule as follows.

AMENDED NOTICE OF HEARING

The Director hereby gives notice that a hearing will be held **June 28, 2016, beginning at 9:00 a.m. (MDT)**, and continuing on **June 29, 2016, if necessary**, at the Butte County High School Auditorium, located at 120 South Water Street, Arco, Idaho, 83214. The presiding officer will be Director Gary Spackman.

The hearing will be held in accordance with provisions of Chapters 2 and 17, Title 42 and Chapter 52, Title 67, Idaho Code, and the adopted Rules of Procedure of the Department, IDAPA 37.01.01. A copy of the Rules of Procedure may be obtained from the Department upon request.

| June 6, 2016 | Deadline for water users who wish to participate in the hearing to submit to the Department a notice of intent to participate ("NOI"). The NOI must expressly state whether the water user supports or challenges the Preliminary Order. On May 20, 2016, the Big Lost River Irrigation District ("BLRID") submitted to the Department <i>BLRID's Petition to Intervene</i> ("Petition"). By June 6, 2016, BLRID must supplement its Petition by submitting to the Department a document stating whether BLRID supports or challenges the Preliminary Order. |
| June 13, 2016 | Deadline for anyone who submits a NOI to submit to the Department a list of witnesses they may call at hearing. By this deadline, the Department will also identify a list of employees that may testify at hearing. |
| June 13, 2016 | Deadline for anyone who submits a NOI to identify documents they intend to rely upon at hearing. Given the short timeframes associated with the schedule for hearing in this matter, the Director may allow supplements to document lists after this date. |
| June 24, 2016 | Deadline for anyone who submits a NOI to serve copies of the exhibits they intend to rely upon at hearing to the Department and others who have submitted a NOI. Three copies of each exhibit |

must be physically received by the presiding officer by this deadline. The presiding officer's mailing address is P.O. Box 83720, Boise, Idaho 83720-0098. By June 24, 2016, the Department will serve a copy of the Department's exhibits on those who have submitted a NOI.
