PREHEARING SCHEDULING ORDER**


COMES NOW, Idaho Power Company, by and through its counsel of record, and hereby responds to the Motion to Amend filed on March 29, 2013.

Idaho Power Company ("Company") supports the Movant's request to amend with respect to the identification of witnesses and the location of the hearing. As to the modification of the hearing dates, the Company would note with the timing of the Motion and the extent of

preparation to date, Parties may have anticipated the length of the hearing on the issue before the hearing officer. As such, the Company representatives' availability is limited. If the hearing start date is moved from April 15, 2013, the Company would request that the hearing recess the afternoon of April 18, 2013 at 5:00 p.m. and reconvene on Monday, April 22, 2013.
