



1. The Idaho Water Resource Board has filed a Motion to Amend Its Petition to Intervene. Twin Falls Canal Company and North Side Canal Company object to the Petition and will file their objection October 7, 2009. The Water Resource Board shall file its response within one week. The matter will be decided on the filings of the parties unless oral argument is requested by the Hearing Officer.
2. Hearing on any Motions for Summary Judgment shall be heard January 22, 2010, at 10:00 a.m. The timing for filing any Motions for Summary Judgment and the responses and briefing shall comply with the Idaho Rules of Civil Procedure.
3. Discovery, including the answers to requests for discovery, shall conclude by December 4, 2009. The conduct of discovery shall comply with the Idaho Rules of Civil Procedure.
4. A further Status Conference shall be held upon the request of any party.


