Re: Curtailment Order In the Matter of Requiring Measuring Devices for Ground Water Diversions in Water Districts Nos. 31, 34, 100, 110, 120, 130 and 140

Dear Water User,

You are receiving this letter because your ground water diversion(s) is not being measured as required by previous orders issued by the Director ("Director") of the Idaho Department of Water Resources ("Department"). Enclosed is a *Curtailment Order In the Matter of Requiring Measuring Devices for Ground Water Diversions in Water Districts Nos. 31, 34, 100, 110, 120, 130 and 140* ("Curtailment Order") issued by the Director on August 31, 2018.

The Curtailment Order directs watermasters to curtail water rights at points of diversions listed in Attachment A of the Curtailment Order beginning September 6, 2018. One or more of your wells is included on this curtailment list. Watermasters will curtail diversions of ground water until an acceptable measuring device is installed or until an acceptable request for variance or extension is submitted to the Department, or watermaster, and is approved. Watermasters will contact users in their water district beginning September 6, either by phone or in person, to confirm when curtailment will take place.

Please contact the Department or your water district watermaster if you have questions.

Re: Curtailment Order and Watermaster Guidance to Curtail Diversions that are not Compliant with ESPA Measurement Order

Dear Watermasters,

The Director of the Idaho Department of Water Resources ("Department") issued the attached *Curtailment Order In the Matter of Requiring Measuring Devices for Ground Water Diversions in Water Districts Nos. 31, 34, 100, 110, 120, 130 and 140* ("Curtailment Order") on August 31, 2018. **The Curtailment Order directs watermasters to curtail water rights at points of diversions listed in Attachment A of the Curtailment Order beginning September 6, 2018.** Curtailment at each diversion shall be enforced until an acceptable measuring device is installed or the owner of the diversion submits to the Department or watermaster a request for variance or extension and the Department approves such request.

Watermasters shall adopt the following guidance with respect to curtailments:

- Contact the owners or operators of each diversion or well listed in Attachment A of the Curtailment Order either by phone or in person to confirm when curtailment will take place.
- Watermasters shall shut off and lock or seal each well subject to curtailment, even if the well may be off for the rest of the irrigation season. If the well cannot be locked or sealed, identify the method in which water use may be monitored during the remaining season (i.e. use of dedicated power meter or other options). Locking or sealing may be accomplished using security seals, locks or cables on electrical switch controls or by closing and locking/sealing main pipe valves. A Curtailment Notice card ("Red Card") should be placed at each diversion in a noticeable location. Document any curtailment with photos that show method of closure.
- The watermaster or watermaster's assistants should coordinate shut-off and locking with the owner or operator present if possible. The watermaster should not delay curtailment based on the owner's or operator's schedule.

- When feasible the regulation of water users and enforcement action should be carried out by the watermaster. If the watermaster is unable to regulate all non-compliant water users by him/herself, staff assisting the watermaster in enforcement should coordinate closely with the watermaster prior to taking action. If site visits by supporting staff are required, staff should enforce curtailment requirement in teams of two. In the event an owner/operator is uncooperative or refuses access or entry to the well, the watermaster should consult with Department staff (contact Tim Luke, Rob Whitney or Brian Ragan).
- If the watermaster encounters circumstances that suggest enforcement action pursuant to Idaho Code § 42-1701B is preferable to curtailment (e.g. curtailing a diversion would cut off a source of drinking/domestic water or curtailment is not physically possible), the watermaster may refer the matter to Department Compliance Bureau staff. If a formal administrative enforcement action becomes necessary, please coordinate with appropriate Department Compliance Bureau staff (either Tim Luke, Rob Whitney, Brian Ragan or Cherie Palmer). Please document all attempts to curtail the well and the obstacles or reasons why physical curtailment cannot be achieved.

Please contact Department Compliance Bureau staff members Tim Luke, Rob Whitney or Brian Ragan regarding any questions you may have about the Curtailment Order and any subsequent curtailment procedures. Successful implementation of this Curtailment Order is currently one of the Department's highest priorities.

Measurement Order at 13.² The Director specified that measuring devices acceptable to the Department are flow meters identified in the Department’s *List of Approved Closed Conduit Flow Meters* (Version 2.9 updated 6-6-2016). *Id.* The Director explained that the Department would consider a request for variance of the Department approved flow meter requirement upon submittal of a written plan to the Department. *Id.* at 13-14.³ The Director also explained that, if a water user could not comply with the specified deadlines (“start of the irrigation season” for irrigation diversions or “January 1, 2018” for non-irrigation diversions), the Department would consider requests for extension submitted to the Department in writing. *Id.* at 14.

On March 2, 2018, the Department sent a letter to owners of non-irrigation diversions who were required to install acceptable measuring devices by January 1, 2018, but who, according to the Department’s records and communications with water district staff, had not installed the required measuring device or requested a variance. The letter informed the owners that, to avoid potential curtailment by the watermaster, they had to either: 1) within fifteen days of the letter, submit documentation that the required measuring device had been installed, 2) install an approved measuring device and notify the watermaster by March 15, 2018, or 3) submit a variance or extension request by March 15, 2018.

On March 27, 2018, the Department sent a letter to owners of irrigation diversions who were required to install acceptable measuring devices by the start of the 2018 irrigation season, but who, according to the Department’s records and communications with water district staff, had not installed the required measuring device or requested a variance. The letter informed the owners that, to avoid potential curtailment by the watermaster, they had to install and maintain the required measuring device before diverting water for the 2018 irrigation season. The letter also requested that the owner either: 1) request an inspection if the measuring device had been installed, 2) document any measuring device installation currently underway and the date installation would be complete, or 3) submit a request for variance within fifteen days of the letter.

On March 30, 2018, the Department sent a follow-up letter to owners of non-irrigation diversions who were sent the March 2, 2018, letter described above. The letter informed the owners that, according to the Department’s records and communications with water district staff, the owners still had not installed the required measuring device or requested a variance. The

² The measurement and reporting required by the Measurement Order are waived for the following ground water uses and diversions:

- a. Domestic and stockwater uses as defined by Idaho Code § 42-111;
- b. Diversions of ground water or water systems with multiple diversions irrigating less than or equal to five (5) acres; and
- c. Diversions of ground water or water systems with multiple diversions delivering ground water for any purpose other than irrigation that divert less than or equal to 0.24 cubic feet per second (approximately 108 gallons per minute).

³ The Measurement Order specifies that requests for variance must be submitted to the Department on the Department’s form titled “Request for Variance of IDWR Approved Flow Meter Requirement for Irrigation Wells” available on the Department’s website or upon request. *Measurement Order* at 14.

letter informed the owners that, on or after April 9, 2018, and pursuant to Idaho Code § 42-701(3), the watermaster could shut off and refuse delivery of water from each diversion described in the letter unless an acceptable measuring device is installed. The letter also informed the owners that, if an acceptable measuring device is installed, the owner must notify the Department or watermaster on or before April 9, 2018.

On May 17, 2018, the Department sent a follow-up letter to owners of irrigation diversions who were sent the March 27, 2018, letter described above. The letter informed the owners that, according to the Department's records and communications with water district staff, the owners still had not installed the required measuring device or requested a variance. The letter informed the owners that, on or after June 1, 2018, and pursuant to Idaho Code § 42-701(3), the watermaster could shut off and refuse delivery of water from each diversion described in the letter unless an acceptable measuring device is installed. The letter also informed the owners that, if an acceptable measuring device is installed, the owner must notify the Department or watermaster on or before May 27, 2018.

ANALYSIS

In accordance with Idaho Code § 42-701(3) and as described above, the Department sent letters to the owners of non-irrigation and irrigation diversions listed in Attachment A constituting ten days' notice "within which to begin and diligently pursue to completion the construction or installation of the required device or devices or to begin and diligently pursue to completion a remedy to such defects as exist in accordance with said notice." I.C. § 42-701(3). As of the date of this order, according to Department records, flow meter inspections in July and August 2018, and communications with water district staff, the owners listed in Attachment A have not installed the required measuring devices, did not within ten days' notice from the Department begin "to diligently pursue to completion the construction or installation of the required measuring devices," and have not received an approved variance or extension from the Department. *Id.* Therefore, pursuant to Idaho Code § 42-701(3), the Director will "order the duly qualified and acting watermaster of the water district to shut off and refuse to deliver at the point of diversion, the water owned by such appropriator or user until the user does construct and maintain such headgates, controlling works or measuring devices or remedy the defects which exist. . . ." *Id.*

ORDER

Based upon and consistent with the foregoing, IT IS HEREBY ORDERED that the watermasters of the water districts responsible for administering water rights listed in Attachment A shall, beginning September 6, 2018, curtail those water rights at the points of diversion listed in Attachment A until an acceptable measuring device is installed as described in the Department's *List of Approved Closed Conduit Flow Meters* (Version 2.9 updated 6-6-2016) or the owner submits to the Department or watermaster a request for variance or extension as described in the Measurement Order and the Department approves such request. If a watermaster encounters circumstances that suggest enforcement action pursuant to Idaho Code § 42-1701B is preferable to curtailment, the watermaster may refer the matter to Department Compliance Bureau staff. *See* Idaho Code § 42-701(3). Pursuant to Idaho Code § 42-1701A(3), any person aggrieved by this order may, within fifteen days after receipt of written notice of the

order or receipt of actual notice, file with the Director a written petition stating the grounds for contesting the order and requesting a hearing.
