Dear Water User:

The Idaho Department of Water Resources (“IDWR”) has issued the enclosed Preliminary Order Amending Measuring Device Installation Dates (“Order”) for ground water diversions in the Malad Valley Water Measurement District (“MVWMD”). The Order extends the deadlines from 2021 to 2022 for installing measuring devices or flow meters on wells. The enclosed Order is a preliminary order pursuant to Section 67-5243, Idaho Code. Any party may file a petition for reconsideration of a preliminary order as explained in the enclosed information sheet.

1. On November 9, 2018, the Idaho Department of Water Resources (“Department”) issued a *Preliminary Order Creating Water Measurement District and Requiring Installation of Measuring Devices* (“Measurement Order”).<sup>1</sup> The Measurement Order created the Malad Valley Water Measurement District (“MVWMD”), effective November 4, 2019, the date designated for the first annual meeting of the MVWMD. The MVWMD includes all ground water rights within the Malad River drainage, except the following:

- a. Domestic and stockwater uses as defined by Idaho Code §§ 42-111 and 42-1401(11);
- b. Irrigation uses of five acres or less<sup>2</sup>; and
- c. Non-irrigation uses where the total authorized water right rate of diversion is equal to or less than 0.24 cfs (approximately 108 gallons per minute).<sup>3</sup>

2. The Measurement Order required the owners of ground water rights in the MVWMD, except those ground water rights, uses and diversions identified in item 1.a. through 1.c. above, to install an acceptable measuring device on each irrigation diversion or well by the start of the 2021 irrigation season, and on each non-irrigation well by January 1, 2021.

3. In preparation for the first annual MVWMD meeting, Department staff determined that extending the time to install measuring devices or flow meters on wells in the MVWMD will improve measuring device compliance.

4. On November 4, 2019, Department staff met with ground water users at the first annual MVWMD meeting in Malad City, Idaho, to present information about the MVWMD and ground water measurement requirements. The Department announced at that meeting it would extend the deadlines for installation of ground water measuring devices in the MVWMD from 2021 to 2022. The extended deadline will give water users more time to plan and budget for installation

<sup>2</sup> A common point of diversion used for multiple irrigation rights where each individual right is five acres or less must be measured if the sum of the irrigated acres pursuant to the authorized rights exceeds five acres.

<sup>3</sup> A common point of diversion serving multiple non-irrigation uses must be measured if the total diversion rate pursuant to the authorized right(s) is greater than 0.24 cfs.

of measuring devices or flow meters, especially those users who own multiple wells or who need to modify well discharge systems to accommodate the installation of flow meters. The extended deadline allows additional time for the MVWMD to apply for cost-share grants or other financial assistance for purchase and installation of flow meters.

## ORDER

IT IS HEREBY ORDERED that:

1. The holders of ground water rights in the MVWMD, except those ground water rights, uses and diversions identified in item 1.a. through 1.c above, shall install and maintain on each point of diversion or well, a measuring device of a type acceptable to the Department. **Owners of irrigation diversions** that are required to be measured shall install acceptable measuring devices **by the start of the 2022 irrigation season. Owners of non-irrigation diversions** that are required to be measured shall install acceptable measuring devices **by January 1, 2022.**

2. Measuring devices acceptable to the Department for wells required to be measured shall be flow meters identified in the Department's *List of Approved Closed Conduit Flow Meters* (copy attached).<sup>4</sup> These specifications apply to wells used for both irrigation and non-irrigation water uses.

3. The Department will consider a request for variance of the Department's approved flow meter requirement upon submittal of a written request to the Department. Acceptable variances may include the following methods or devices:

- a. Use of an hour meter (time clock) for open discharge wells with electric pumps that operate at a constant rate of flow; or
- b. Use of an acceptable closed conduit flow meter installed prior to the date of this Order; or
- c. Use of power consumption coefficient for irrigation wells with a single operating condition, and an electric pump connected to a dedicated demand meter.

4. All requests for variance must be received by the Department by **July 1, 2021**. The Department will consider requests on a case-by-case basis. Variance requests proposing use of an existing flow meter will be denied unless the existing meter is tested and satisfies the Department's established standards for accuracy and the manufacturer installation specifications. Existing meters that do not satisfy the established standard for accuracy and the manufacturer specifications must be replaced with a meter from the Department's *List of Approved Closed Conduit Flow Meters*. Requests for variance must be submitted using the Department's form "*Request for Variance of IDWR Approved Flow Meter Requirement*" available on the Department's website or upon request.

5. If a user cannot comply with the deadlines in paragraph 1, the Department may grant an extension. An extension request for each diversion must be submitted to the Department by **July 1, 2021**. Extension requests will be considered on a case-by-case basis. Extension requests must be submitted using the Department's form "*Request for Extension of Time to Install IDWR-Approved Flow Meter*" available on the Department's website or upon request. Conditions that may result in the Department granting an extension include, but are not limited to the following:

- a. The diversion is unused;
- b. Unique site specific condition(s) prevent accurate water measurement; or
- c. Delays caused by requirements of other government entities.

6. This Order only amends the measuring device installation dates and deadlines for filing variance or extension requests set forth in the Measurement Order. All other provisions of the Measurement Order remain in full force and effect.

## **EXPLANATORY INFORMATION TO ACCOMPANY A PRELIMINARY ORDER**

(To be used in connection with actions when a hearing was **not** held)

(Required by Rule of Procedure 730.02)

The accompanying order or approved document is a "**Preliminary Order**" issued by the department pursuant to section 67-5243, Idaho Code. **It can and will become a final order without further action of the Department of Water Resources ("department") unless a party petitions for reconsideration, files an exception and brief, or requests a hearing as further described below:**

### **PETITION FOR RECONSIDERATION**

Any party may file a petition for reconsideration of a preliminary order with the department within fourteen (14) days of the service date of this order. **Note: the petition must be received by the department within this fourteen (14) day period.** The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See Section 67-5243(3) Idaho Code.

### **EXCEPTIONS AND BRIEFS**

Within fourteen (14) days after: (a) the service date of a preliminary order, (b) the service date of a denial of a petition for reconsideration from this preliminary order, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration from this preliminary order, any party may in writing support or take exceptions to any part of a preliminary order and may file briefs in support of the party's position on any issue in the proceeding with the Director. Otherwise, this preliminary order will become a final order of the agency.

### **REQUEST FOR HEARING**

Unless a right to a hearing before the Department or the Water Resource Board is otherwise provided by statute, any person aggrieved by any final decision, determination, order or action of the Director of the Department and who has not previously been afforded an opportunity for a hearing on the matter may request a hearing pursuant to section 42-1701A(3), Idaho Code. A written petition contesting the action of the Director and requesting a hearing shall be filed within fifteen (15) days after receipt of the denial or conditional approval.

### **ORAL ARGUMENT**

If the Director grants a petition to review the preliminary order, the Director shall allow all parties an opportunity to file briefs in support of or taking exceptions to the preliminary order and may schedule oral argument in the matter before issuing a final order. If oral arguments are to be heard, the Director will within a reasonable time period notify each party of the place, date and hour for the argument of the case. Unless the Director orders otherwise, all oral arguments will be heard in Boise, Idaho.

## **CERTIFICATE OF SERVICE**

All exceptions, briefs, requests for oral argument and any other matters filed with the Director in connection with the preliminary order shall be served on all other parties to the proceedings in accordance with IDAPA Rules 37.01.01302 and 37.01.01303 (Rules of Procedure 302 and 303).

## **FINAL ORDER**

The Director will issue a final order within fifty-six (56) days of receipt of the written briefs, oral argument or response to briefs, whichever is later, unless waived by the parties or for good cause shown. The Director may remand the matter for further evidentiary hearings if further factual development of the record is necessary before issuing a final order. The department will serve a copy of the final order on all parties of record.

Section 67-5246(5), Idaho Code, provides as follows:

Unless a different date is stated in a final order, the order is effective fourteen (14) days after its service date if a party has not filed a petition for reconsideration. If a party has filed a petition for reconsideration with the agency head, the final order becomes effective when:

- (a) The petition for reconsideration is disposed of; or
- (b) The petition is deemed denied because the agency head did not dispose of the petition within twenty-one (21) days.

## **APPEAL OF FINAL ORDER TO DISTRICT COURT**

Pursuant to sections 67-5270 and 67-5272, Idaho Code, if this preliminary order becomes final, any party aggrieved by the final order or orders previously issued in this case may appeal the final order and all previously issued orders in this case to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or
- iv. The real property or personal property that was the subject of the agency action is located.

The appeal must be filed within twenty-eight (28) days of this preliminary order becoming final. See section 67-5273, Idaho Code. The filing of an appeal to district court does not itself stay the effectiveness or enforcement of the order under appeal.
