Good Afternoon,

The Idaho Department of Environmental Quality (DEQ) appreciates the opportunity to participate and comment on the Idaho Department of Water Resources (IDWR) 37.03.07 Negotiated Rulemaking Public Meeting on June 2, 2021 and the associated draft strawman v2.0. As such, we respectfully provide the following comments:

- In general, DEQ appreciates the cooperation with IDWR to try and better align our agencies' permitting requirements to the extent practicable, because most IDWR permittees are also be required to obtain coverage under the IPDES General Permit for Small Suction Dredge Miners in Idaho (IDG370000).
- DEQ believes there are two typos in the draft strawman v2.0:
 - 37.03.07.061.01 should state "...by the Department of <u>or</u> Board, or as..."
 - 37.03.07.061.02 should state "...(15) HP or less below the mean high water mark, or the use of and non-powered..."
- DEQ believes the that any "power sluice" identified in IDWR's draft strawman v2.0 for rule 37.03.07.055.06, 061.01., 02., 03., and 04. that does not fit the definition of a small suction dredge in the IPDES General Permit IDG370000 and accompanying fact sheet are not covered by the General Permit as currently written.
 - General Permit IDG370000 Authorizes discharge for, "...small suction dredges in Idaho (intake nozzle size of 5 inches in diameter or less (or the diametrical equivalent defined in the general permit) and with equipment rated at 15 horsepower or less)..."
 - Section III. of the fact sheet Identifies that throughout the permit EPA, "Changed 'placer mining' to 'suction dredging' to more precisely describe the activity being covered by the GP."
 - IV.A of the fact sheet "Suction dredges consist of a supporting hull with a mining control system, excavating and lifting mechanism, gold recovery circuit, and waste disposal system. All floating dredges are designed to work as a unit to extract, classify, beneficiate ores, and discharge."
 - Section VI.B of the fact sheet "...a suction dredge is a mechanical device that floats on the stream surface and pumps stream water and stream bed material through a suction intake conduit to a sluice box to process and recover gold or other minerals. The discharge from suction dredges consists totally of stream water and bed material immediately released back into the receiving water."
- Any proposed small scale mining operation that does not meet the definition of a small suction dredge according to the IPDES general permit and fact sheet, would need to apply for an IPDES individual permit.
- DEQ plans to reissue the current IPDES General Permit IDG370000 before its expiration in 2023. The reissued General Permit will go through the public comment and review process, which may result in changes to the permit's terms and conditions, referenced above.
