**NOTICE OF STATUS
CONFERENCE**

On October 8, 2020, the Idaho Department of Water Resources (“Department”) issued a *Preliminary Order Denying Transfer* in the above captioned matter.

On October 22, 2020, Suez Water Idaho Inc. (“Suez”) timely filed *Suez’s Petition for Reconsideration and Request for Hearing*.

On November 12, 2020, the Director issued his *Order Granting Request for Hearing* (“Order”). In the Order, the Director instructed the parties to provide the Director with available dates for a prehearing conference to be held in January of 2021.

The Department and the parties participated in a telephonic prehearing conference on January 12, 2021, at 1:30 p.m. (MST). The Department and the parties discussed the path forward and agreed that Department and Suez representatives should hold informal proceedings as authorized by Rule 101 of the Department’s Rules of Procedures, IDAPA 37.01.01.101, to discuss possible resolution of the matter. The Department and the parties agreed to schedule a status conference in two months to give the Department and Suez representatives adequate time to hold informal discussions.

NOTICE OF STATUS CONFERENCE

The Director hereby notifies the parties that a status conference will be held on **March 11, 2021, at 1:30 p.m. (MST)**, via teleconference. Based on the consensus of the participants, a meeting between Department and Suez representatives will take place before the status conference.

All parties to the matter must be represented at the status conference by telephone (please dial **1-720-279-0026** and enter guest code followed by the pound sign when prompted: **234278#**).

The status conference will be held in accordance with provisions of Chapters 2 and 17, Title 42 and Chapter 52, Title 67, Idaho Code, and the adopted Rules of Procedure of the Department, IDAPA 37.01.01. The status conference will be conducted in a manner that meets the accessibility requirements of the Americans with Disabilities Act.
