PIONEER'S RESPONSE TO UNITED WATER'S MOTION FOR CLARIFICATION OF PARTY STATUS

## I. INTRODUCTION

This is the response of Pioneer Irrigation District ("Pioneer") to United Water Idaho's Motion for Clarification of Part Status.

## II. DISCUSSION

Pioneer disagrees with United Water Idaho's ("UWID") comments regarding
Pioneer's Petition for Reconsideration. First, the UWID comments inappropriately attempt to
provide additional substantive argument on the Petition, despite UWID's position at the
April 13, 2012 status conference that the matter had been fully briefed. Contrary to UWID's
comments in its motion, the sanctions ordered by Peter Anderson were not the result of "serious
discovery misconduct." Pioneer reaffirms that it did nothing improper in the discovery responses
it provided to UWID.

Moreover, Pioneer believes that UWID is attempting to circumvent the determination of the Director to review the Petition and act on it. In this regard, the Affidavit of Counsel filed concurrently with this Response demonstrates UWID's intent.
