**ERRATA - UNITED WATER'S
STATEMENT UPDATING AND
EXPLAINING THE IMAP RELAUNCH**

On August 14, 2012 United Water filed *United Water's Statement Updating and Explaining IMAP Relaunch* (including Exhibits A through F attached thereto) with the Idaho Department of Water Resources ("Department"). Subsequent to that filing, United Water Idaho Inc. ("United Water") identified the errata outlined below.

I. FLOATING FEATHER WELL

Exhibit F (2012 Pink Line Map) on page 124 of the above-referenced statement did not accurately reflect the proper location of the Floating Feather well in Eagle, Idaho. Accordingly, we attach a revised Exhibit F (2012 Pink Line Map) reflecting the correct placement of the Floating Feather well. The Floating Feather well location has been moved ¼ mile west from the

previous map version. It is now correctly depicted inside the existing certificated boundary of United Water's service area in the vicinity of Eagle, Idaho.

United Water has made a large scale version of the referenced revised map available to the Department. It is United Water's understanding that a digitized computer version of the referenced revised map will be made available to interested parties and the public on the website the Department has set up for sharing public information regarding this proceeding:

II. LICORICE AND DURHAM WELLS

Exhibit F (2012 Pink Line Map) correctly labeled the Licorice and Durham wells in the eastern portion of United Water's service area. United Water acquired these wells from Barber Water Corp. However, they are indentified incorrectly on Table 9 (page 19), Table 10 (page 20), and Table 17 (page 26) of *United Water's Statement Updating and Explaining the IMAP Relaunch*. Accordingly, all references in that statement to "Barber Hills #1" (or "Barber #1") should be corrected to read "Durham," and all references to "Barber Hills #2" (or "Barber #2") should be corrected to read "Licorice." In addition, the reference to "the Barber Hills water system" in the text on page 20 should be corrected to refer to "the Barber Water Corp. water system." Likewise, the reference to "Barber Hills" in the section heading on page 19 (and in the corresponding table of contents) should be corrected to refer to "Barber Water Corp." These are simply labeling errors and have no substantive effect.
