ORDER VACATING HEARING DATE AND ASSOCIATED DEADLINES AND NOTICE OF STATUS CONFERENCE

On November 15, 2017, the Hearing Officer issued a Notice of Hearing, scheduling an administrative hearing in this case for May 29-31, 2018. Since that time, the parties have participated in ongoing discussions, seeking an informal resolution of the contested case.

On May 11, 2018, the Applicant notified the Hearing Officer that the parties are still actively engaged in comprehensive settlement discussions and proposed advancing the hearing date and, instead, conducting a status conference on one of the days currently scheduled for the hearing, preferably May 31st. One of the remaining protestants, Boise Project Board of Control, supported the proposal to advance the hearing date. The other remaining protestant, City of Middleton, also supported the proposal and asked that the status conference be scheduled for May 30th or 31st.

Pursuant to Rule 413 of the Department's Rules of Procedure (IDAPA 37.01.01), the hearing officer has the authority to schedule hearing dates and mandatory disclosures. Because the parties are actively engaged in settlement discussions, it is sensible to vacate the rapidly-approaching hearing date and reschedule the hearing if settlement negotiations are unsuccessful.

ORDER

IT IS HEREBY ORDERED that the hearing scheduled for May 29-31, 2018 and the mandatory disclosures scheduled for May 15, 2018 are VACATED.
