Executive Order 2020-01 Zero-Base Regulation









- Signed by Governor in January 2020
 <u>https://gov.idaho.gov/wp-</u> content/uploads/sites/74/2020/01/eo-2020-01.pdf
- Requires all agencies to undertake "zero-base regulation" review of all their respective rules over a five-year period.
- 2024 is the fourth year of the five-year review schedule.




Negotiated Rulemaking

- Purpose is to get feedback from the public.
- Intended to improve the substance of the rule.







• Informal part of the rulemaking process that precedes all formal rulemaking proceedings.















Beneficial Use Examination Rules

• Section 42-217(1), Idaho Code

- The permit holder shall submit a statement ... that the permit holder has used such water for the beneficial purpose allowed by the permit.

Section 42-217(4), Idaho Code

- The department or the person making such examination ... shall prepare and file a report of the investigation...

Section 42-217a, Idaho Code

- The director shall adopt all necessary rules ... to become certified water right examiner.











Beneficial Use Examination Rules

• Section 42-219, Idaho Code

- Upon receipt ... of all evidence in relation to such final proof, ... if the department is satisfied that the law has been fully complied with and that the water is being used at the place claimed and for the purpose which it was originally intended, the department shall issue ... a license corresponding to the beneficial use.

Other Sections

- 42-218a permits lapsed more than 60 days need to have a certified exam to be reinstated.

- 42-221 filing fees for proof statements.





Rule 035 – "Major" Changes

- Strawman Version 1 contained language relating to domestic or municipal use.
 - iv. For multi-home domestic or municipal use, the volume may include up to 0.6 af for in-home use and 0.6 af for developed yard or landscape irrigation for each lot with an existing stub-in water service line and foundation where each home's use will meet the definition of Section 42-111(a), Idaho Code.
- This language is removed from Strawman Version 2.















Rule 035 – New Content (page 5)


- 01.j.ix. Ground water recharge water right owned by the Idaho Water Resource Board
 - Added based on comments received
- 01.i.ii. For heating, cooling, or commercial snowmaking the volume may be adjusted to account for documented weather conditions...
 - Comments received supported this language

Negotiated Rulemaking Next Steps

- Written comments on Strawman can still be submitted
 - Submitted to <u>rulesinfo@idwr.Idaho.gov</u>
 - Reference the rule chapter: IDAPA 37.03.02.
- IDWR will create a Proposed Rule from the Strawman and received comments.
- The Proposed Rule will be published in the Administrative Bulletin in October.
 - 21 day comment period.
 - Comment deadline for October publication is October 23, 2024.
- IDWR will create and submit a Pending Rule to be reviewed by legislature.




















IDWR Rulemaking 2024/2025
